Description

The E-BOX XL MODULAR as a supplement to the E-BOX MODULAR is an enclosure concept with 3 to 6 installation points for all RAFIX 22 FS+/FSR control devices. It is used where individual control devices are required at remote locations - for example, emergency stop applications along a production line or at a safety fence. The compact dimensions of the E-BOX XL are based on the edge dimensions of a 40 mm profile rail. Installation is quick and easy - thanks to the modular system consisting of the lower and upper housing sections, QC contact blocks and RAFIX 22 FS+/FSR actuators, which are installed and wired manually.

Individually configurable and combinable

- Use of RAFIX 22 FS+ actuators and RAFIX 22 FS+ QC switching elements for any installation location
- Manual wiring with cable gland (Ø 7-13 mm clamping range)
- RAFIX 22 FS+ / RAFIX 22 FSR actuating elements, RAFIX 22 FS+ QC switching elements, LED clips and blade receptacles must be purchased separately

Scope of delivery

Lower housing section, upper housing section, cable gland, emergency stop adhesive label and screws for the housing connection

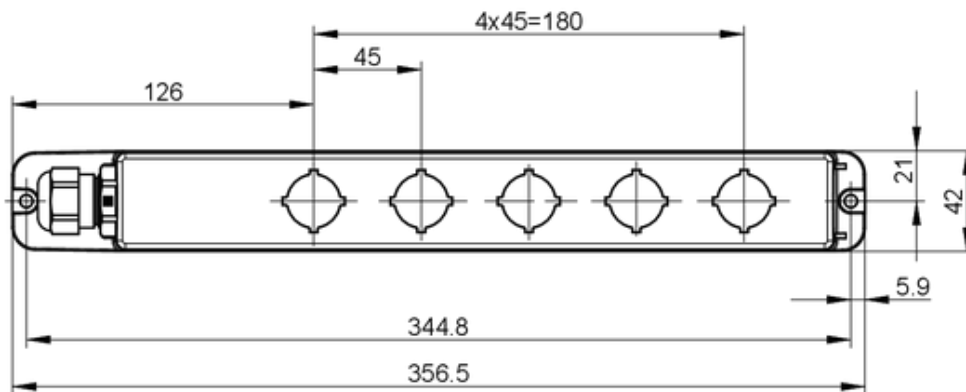

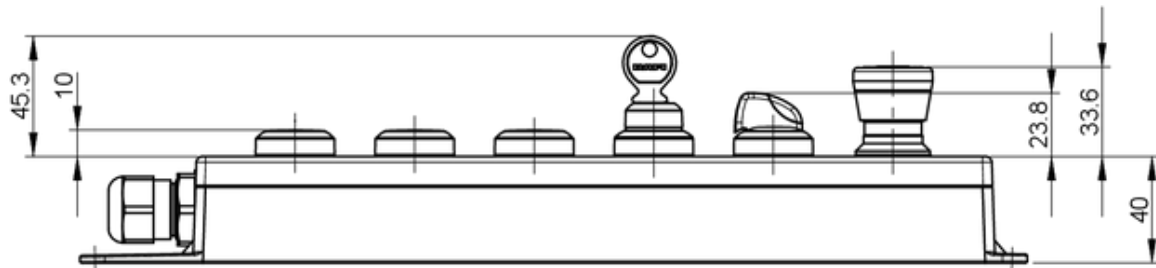

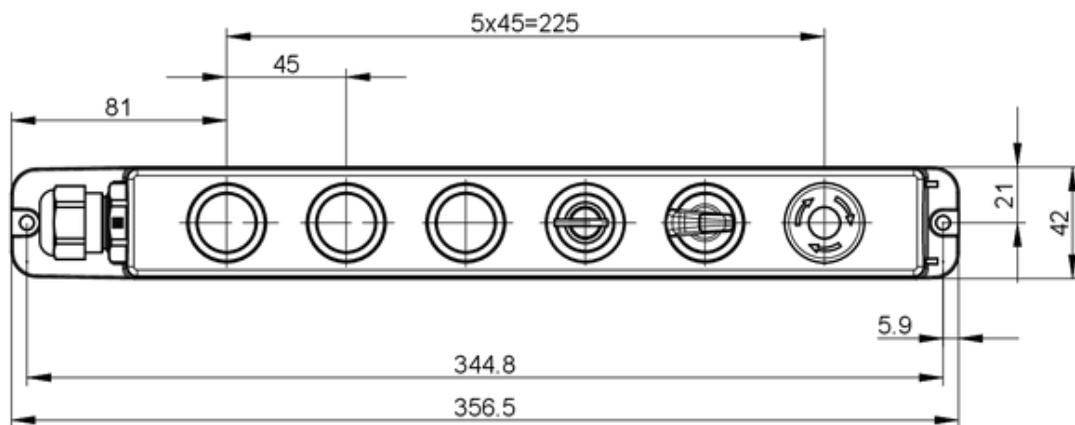

System drawing

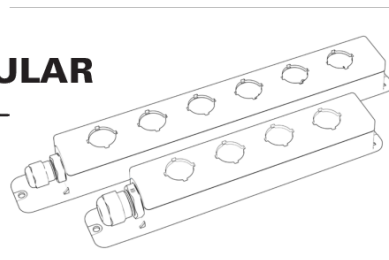

**E-BOX XL MODULAR
OPERATING MANUAL**



1. Safety

1.1 Use

The RAFI E-BOX XL MODULAR is an housing system in which control and signaling devices can be custom installed according to the requirements of the machine or system, allowing the operator to control such a system. To ensure safe operation and prevent personal injury, the E-BOX XL MODULAR housing system must be securely bolted to the system or machine by the installer using all the screw connections provided.

Use of the E-BOX XL MODULAR for purposes other than those for which it is intended will invalidate its associated declaration of conformity. The E-BOX XL MODULAR is not subject to the Machinery Directive.

Emergency stop buttons can also be installed in the housing system. These are electromechanical switching devices for the protection of persons on or near machines. They are used to switch off/shut down machines and systems in order to avoid or reduce emerging or existing hazards for persons or damage to the machine or the workpiece.

For installation and commissioning, as well as regular technical inspections, the (inter)national legal regulations apply, in particular

- The Low-Voltage Directive 2014/35/EU
- The safety regulations, and
- The accident prevention regulations/safety rules

Manufacturers and operators of machines on which emergency stop buttons are used are responsible for observing the operating manual for emergency stop control components, as well as for complying with the applicable safety regulations and rules.

! In particular, the relevant requirements for the installation and operation of emergency stop buttons must be observed for the intended use:

- EN 60204-1
- EN13849-1
- EN ISO 13850

! Disconnect the system and device from the power supply before starting installation.

If an emergency stop button is installed in the E-BOX XL MODULAR, the safety instructions in the operating instructions for the emergency stop button must be observed.

1.2 Safety provisions

This operating manual applies to the housing systems of the E-BOX XL MODULAR series and the correct assembly of the associated actuators and switching elements. When installing emergency stop buttons, the separate operating manual for the emergency stop device must be observed. The operating manual must be made available to the person installing the housing system with actuators, switching elements, and optional emergency stop. Please read it carefully and keep it for future reference.
